

# **Consulting Services Agreement**

VIRTUAL VISION co::Lab

NOVEMBER 11, 2010







#### **PURPOSE**

The purpose of the phase one "Vision co::Lab" is to train and equip local leaders to navigate their ministry through the complete assessment, articulation, and alignment of the church's Vision Frame.

#### **PROCESS**

Auxano recommends a phase one journey that trains and equips church leaders to navigate their ministry to develop their Vision Frame. The process consists of six two-hour webinar meetings within a six-month window. The sessions will have a total of eight ministry professionals participating in each meeting. In addition, there will be six 90-minute follow-up Q & A conference calls during which specific challenges or clarifications can be addressed. Each participating leader will have the opportunity to communicate with Will directly at two checkpoints done via 60-minute conference calls. One will be scheduled midpoint during the co::Lab to receive coaching, and one will be at the conclusion of the co::Lab. Dates for these calls will be announced. Sessions will be led by Will Mancini.

#### **DELIVERABLES**

It is from the Vision Frame that the leadership will have the confidence that there is no better way to articulate the identity and direction of the church. It is from the Vision Frame that the church will experience the dynamic of strategic unity. The following list outlines the specific components of the Vision Frame and DNA that participants will be equipped to navigate with their church:

- Kingdom Concept
- Mission
- Values
- Strategy
- Mission Measures
- Vision Proper

In addition to the primary components of the Vision Frame, the process will provide coaching on:

- Identifying Growth Challenges
- · Training for the ongoing process of visioning and planning based on the Vision Frame
- General branding and marketing assessment and recommendations

The consulting process will focus on training for improvement to articulation, alignment of ministry work around each unique articulation, and how to better communicate, implement and measure what has been articulated.

#### INVESTMENT

The base consulting fee for the Auxano Virtual Vision co::Lab is \$300 monthly for six months. The total base fee is \$1,800







## APPENDIX A: THE BENEFITS OF USING AUXANO

- 10. Have you identified a person to help you develop as a senior leader?
